

RIIHAN311F - CONDUCT OPERATIONS WITH INTEGRATED TOOL CARRIER

Course Overview

This course is designed for individuals seeking to conduct operations with integrated tool carrier in coal and metalliferous mining.

Course Duration (approximately 5 days)

Formal Training – Two (2) days

- Day 1 Theory Training
- Day 2 Practical training

Informal Training - Two (2) Days

Supervised Practical (Logbook Hours)

As part of our service we provide the opportunity for learners to develop the necessary practical skills required for assessment. The trainer will specify the amount of practice (log hours) required after formal training is completed and this is dependant on an individual's capability. **Note:** Learners may require <u>additional</u> log hours to those included in the course to achieve competency. Those that require additional practice will be charged at a daily rate or hourly rate depending on their needs.

Rate – Day \$150 per day (7 hours)

Rate – Hourly \$30 per hour (up to 4 hours maximum then a daily rate is applicable)

Note: Informal Training may not happen over consecutive days depending on availability of machinery and equipment.

Assessment – One (1) Day

A written and practical assessment is required to complete the unit successfully.

Topics Covered

- Plan and prepare for integrated tool carrier operations
- Operate integrated tool carrier to lift and move load
- Relocate the integrated tool carrier
- Select, remove and fit attachments
- Conduct housekeeping activities

Resources Required

Student are required to wear appropriate clothing including high visibility long sleeve shirt, long pants, work boots, and hard hat during training. Machinery and equipment is supplied when training at the CCT facility. All written material and stationery is supplied for the course. Learners must provide their own food. Tea and coffee supplied by CCT.

Entry Requirements

CCT policy requires students to be a minimum of 16 years of age prior to enrolling and attending this course due to WHS considerations.
